<p>Fees</p>	<ul style="list-style-type: none"> • Annual Empanelment Fee - Rs 100; Instructor / coach ID Card valid for the year will be issued on payment of registration fee and approval by the KCA Sports sub-committee • Annual Empanelment Fee is payable for the year or part of the year for which empanelment is sought • Monthly Fee: Rs 2,000 • Monthly fees are payable before the 5th of every month; any delay in monthly payment will attract a late fee of Rs 100 for that month • Monthly fees are payable for any month or part of month where coaching is being provided • Above Fee structure is valid from Apr 1, 2017 to Mar 31, 2018
<p>Coaching / Training</p>	<ul style="list-style-type: none"> • Coaching or training in various sporting disciplines may be conducted at the KCA premises • Only coaches & instructors empanelled with KCA Sports & Fitness Centre are authorised to conduct coaching or training in the KCA premises • Payment for coaching or training services rendered will be paid directly to the coach or instructor as per fee to be approved by KCA Sports sub-committee • The fee structure being charged to KCA Sports & Fitness Centre members must be approved by the KCA Sports sub-committee • Coaching or training for some sporting disciplines like Athletics or football may be conducted at grounds outside the KCA premises • KCA bears no responsibility for the services rendered by coaches or instructors; disputes, if any should be sorted out directly by the coach / instructor with the member • Coaches & Instructors must ensure that all members to whom they are providing coaching or instruction have registered with the KCA and have paid their monthly fee for the month in which coaching is being provided
<p>Facilities</p>	<ul style="list-style-type: none"> • Members of the KCA Sports & Fitness Center are free to use all facilities across sports & fitness disciplines • Usage of equipment in the fitness center is subject to the Fitness Center Rules which are available on the Fitness Center Notice Board and the KCA Mumbai website www.kcamumbai.org • Rackets, shuttle-cocks, balls etc are not provided by the KCA Sports & Fitness Center; members are expected to carry / procure these items at their cost • Usage of all sports facilities is at the sole risk & responsibility of the member; the KCA bears no responsibility for any injury or death caused due to usage of the facilities
<p>General</p>	<ul style="list-style-type: none"> • Instructor / coaches empanelled with the KCA Sports & Fitness Centre must carry their ID Cards at all times • If the KCA hall is booked on any day, certain facilities (eg badminton) may be restricted or unavailable for that day; notice of the same will be given on the KCA Notice Board • Membership of the KCA Sports & Fitness Centre as well as empanelment of Instructors is at the sole discretion of the Management; membership applications must be approved by the KCA Sports Sub-committee and may be refused without assigning any reason • Membership of the KCA Sports & Fitness Centre as well as empanelment of Instructors may be terminated at any time due to indiscipline or non-adherence to the Rules and Regulations • Rules and Regulations may be changed from time to time
